## **FREQUENTLY ASKED QUESTIONS**

## 1) WHAT IS THE COMMERCIAL ENERGY OPTIMIZATION PROGRAM?

a) The Commercial Energy Optimization Program (CEOP) offers FREE consulting services to commercial businesses. These services help identify energy-saving opportunities, guide project development, and explore financial options for energy efficiency activities.

b) The CEOP also strives to build capacity within commercial businesses by offering workshops, seminars and training sessions. These activities aim to improve skill sets, enabling businesses to maintain efficiency, lower emissions and achieve cost savings.

#### 2) WHO IS CLEARESULT?

a) We've teamed up with CLEAResult, North America's largest provider of emissionreducing energy solutions, to administer this program.

b) When customers want to join the program, they'll talk to a CLEAResult CEOP representative who will provide personalized support to get started.

## 3) HOW DO I KNOW IF I AM ELIGIBLE TO PARTICIPATE?

- a) The CEOP is for all commercial businesses in Saskatchewan connected to the SaskPower grid. It doesn't matter how big your business is or where you are at in your efforts to be more efficient, there's a service within the program that can assist you.
- b) The CEOP is not for industrial facilities.

#### 4) WHAT IF I'VE ALREADY STARTED DOING ENERGY OPTIMIZATION?

a) No matter where your commercial business is on its energy optimization journey, the CEOP can customize its offering to meet your needs. Contact us for more information.

# 5) CAN I TAKE ADVANTAGE OF THE FINANCIAL INCENTIVES WITHOUT DOING ALL THE OTHER STUFF?

a) Yes, businesses are not required to use support or coaching services to apply for incentives. The proper documentation and savings calculations will need to be submitted along with pre-approval to qualify for the incentive.

## 6) HOW MANY PROJECTS CAN I RECEIVE FUNDING FOR?

a) Custom incentives are calculated individually for each project. If a customer has multiple buildings, they can qualify for multiple projects. The maximum incentive is applied on a per-project basis.

## 7) WHAT IS THE CUSTOM INCENTIVE WORKBOOK?

a) The Custom Incentive Workbook is an Excel Spreadsheet that helps customers and program administrators in assessing potential savings in buildings and determining the financial incentives available for implementing efficiency measures. It includes additional financial information to support decision-making and is a required component of the Custom Incentive applications.

#### 8) HOW DO I GET MY FINAL PAYMENT FOR THE IMPLEMENTATION OF ENERGY MEASURES AND HOW LONG WILL IT TAKE?

a) After implementing the efficiency measures, you must submit documentation for post-project approval. We'll review all required documentation for completeness and approve savings calculations (or conduct measurement and verification if necessary). Once approved, an electronic payment will be made to the provided account. This process typically takes 1-2 weeks once SaskPower receives all required documentation. A CLEAResult program representative is available to assist you in ensuring your submissions are complete and timely. See the Program Guide for more details.

## 9) HOW IS THE PROGRAM BEING FUNDED?

a) We've secured funding from NRCan's Deep Retrofit Accelerator Initiative (DRAI) to support the program. The DRAI funding will cover all Energy Support Services and Energy Coach Services. Funding for the Custom Incentive Service is provided by SaskPower.
