

OIL FIELD RATES

STANDARD RATE

For individual oil and gas production and “in-field” oil pumping and processing services served through SaskPower-supplied transformation – up to and including 3000 kilovolt amperes (kVA).

Note: General service rates apply to individually metered pumping or compression services moving “pipeline quality” oil and gas from the batteries (or gas equivalent) up to and including refineries and gas plants.

BILLING DEMAND

The maximum kVA demand registered in the applicable billing period but will not be less than 60 per cent of the maximum demand registered in the preceding 11 months.

STANDARD RATE

For individual oil and gas production and “in-field” oil pumping and processing services served through customer-owned transformation – up to and including 3000 kilovolt amperes (kVA).

The maximum kVA demand registered in the applicable billing period but will not be less than 60 per cent of the maximum demand registered in the preceding 11 months.

OIL FIELD RATES

25KV/72KV/100KV & ABOVE TIME-OF-USE RATE

For individual oil and gas production and “in-field” oil pumping and processing services served through customer-owned transformation as an alternative to **Oil Field — Standard Rates** and **Oil Field — 25kv/72kv/100kv & Above Rates**.

Note: General service rates will apply to individually metered pumping or compression services moving “pipeline quality” oil and gas from the batteries (or gas equivalent) up to and including refineries and gas plants.

MINIMUM BILL

The basic monthly charge plus the demand charge.

BILLING DEMAND

The monthly billing demand is the monthly recorded demand, but the billing demand should not be less than 75 per cent of the maximum billing demand in the preceding 11 months.

RECORDED DEMAND

The monthly recorded demand is the maximum kVA demand registered during the current month.

OIL FIELD RATES

ON-PEAK ENERGY CONSUMPTION

The monthly energy consumed between the hours of 7:00 to 22:00, Monday through Friday, excluding statutory holidays.

OFF-PEAK ENERGY CONSUMPTION

The monthly energy consumed in all hours except for the on-peak hours.

AVAILABILITY

These time-of-use rates are optional – at the customer’s request. Once a customer requests to change to these rates they must say on for at least one year.

OIL FIELD RATES

25KV/72KV/100KV & ABOVE RATE

For individual oil and gas production and “in-field” oil pumping and processing services served through customer-owned transformation as an alternative to **Oil Field — Standard Rates**.
